**NOTICE UNDER SECTION 708A OF THE CORPORATIONS ACT 2001 (CTH) (ACT)**

As approved by shareholders at the Pilbara Minerals Limited ACN 112 425 788 (ASX:PLS) (**Pilbara Minerals**) Annual General Meeting held on 17 November 2020, Pilbara Minerals has today issued 560,000 ordinary shares issued in the capital of Pilbara Minerals (**Shares**) to Mr Ken Brinsden (and/or his nominee) in lieu of 70% of his cash bonus vested under the FY2020 STI.
