CLEANSING NOTICE

On 2 November 2016 and 3 November 2016, Pilbara Minerals Limited (ASX: PLS) (**Company**) undertook the issue of 104,166,667 and 4,000,000 ordinary fully paid shares respectively (**Securities**).
