PILBARA MINERALS LIMITED (ASX: PLS) 2021 ANNUAL GENERAL MEETING

Instead, a copy of the Notice will be available under the “ASX announcements” section of the Company’s website at www.pilbaraminerals.com.au.

If you have not elected to receive notices by email, a copy of this letter and your personalised proxy form will be posted out to you for your convenience. Shareholders are encouraged to complete and lodge their proxies online or otherwise in accordance with the instructions set out in the proxy form and the Notice.

The Notice is important and should be read in its entirety. If you are in doubt as to the course of action you should follow, you should consult your adviser. 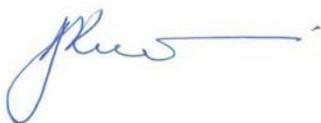
